### **Technology Transfer-Call for Bids**

#### **Guidelines for Submission of Bid and Conditions of the Contract:**

- a) The bid will be submitted in two parts: A) Technical Bid (refer to format Annexure I), and B) Financial Bid (refer to format in Annexure II).
- b) The bidders will clearly mention the capacity of the person signing the bid and source of his/her authority, preferably with a proof.
- c) The successful bidder will need to furnish assurance to commercialize the technology within the set time frame.
- d) The successful bidder will need to deposit an Earnest Money (1/10<sup>th</sup> of the total amount finalized) which will be adjusted in the first ladder of payment.
- e) The technology acquirer will write the name of the University on the products manufactured as "Technology developed by Punjabi University, Patiala, Punjab-INDIA".
- f) The technology acquirer should agree to attend any meetings convened by the University pertaining to the technology, and not assign any independent third party for the working of the technology under reference.
- g) During handholding phase by the University, till pilot/ commercial scale production begins, all visits and stay arrangements to be made and monetarily borne by the acquirer.
