

Statement of Cooperation

Between

Virpurandad Library, Surrey (B.C.), Canada

And

Punjabi University, Patiala India ("PBUI")

This **Statement of Cooperation** is designed to foster a friendly relationship through cooperation in preservation of buildings and materials of Dr. Balbir Singh Sahit Kendra, Dehradun, between Punjabi University of India (PBUI) and Virpurandad Library, Surrey (B.C.), Canada, referred to individually as a "Party" and collectively as the "Parties". Financial obligations will be the fundamental responsibility of Virpurandad Library, Surrey (B.C.), Canada, are assumed under this **Statement of Cooperation**.

The Parties have reached agreement on the following areas of cooperation, subject to mutual consent and the availability of sufficient funding:

1. To ensure the preservation of the buildings included in the complex of Panchavati (Dehradun) and the preservation of manuscripts documents and unpublished and out-of-print writings of Bhai Vir Singh ji and Professor Puran Singh ji. Copyrights of the writings will be based on the copyright regulations.

The natural environment of the Panchavati complex will be preserved.

2. Virpurandad Library will cover the cost of the annual hosting of a literary event to commemorate the memories of Bhai Vir Singh ji, Professor Puran Singh ji, Dr. Balbir Singh ji and Srimati Mohinder Kaur ji.

1 Relationship of the Parties

The Parties agree that this SOC is not intended to, nor shall, create a partnership, joint venture or agency relationship between the Parties.

2 Term and Termination

The SoC shall commence on the date of the latest signature and be in effect for two years, at which time it shall be reviewed for a possible extension.

Either Party may terminate this SOC any time and for any reason with immediate effect by giving ninety (90) days written notice to the other Party.

The termination of the SOC will not affect any rights or obligations under any formal agreement entered between the parties pursuant to this SoC or otherwise. Any such agreements remain in effect according to their respective terms.

3 Coordinating Officers

In order to carry out and fulfil the aims of this SOC, PBUI and Virpurandad Library each appoint the following individuals to communicate in regards to the SoC:

These individuals, or their designate, will be the points of contact for the SoC. Both parties will, to the best of their abilities, notify the other party if the above designate changes.

4 Expenses

Unless the relationship of the Parties results in a formal agreement that specifically provides otherwise, each Party will act as specified herein at its own risk and expense in undertaking any of the activities described herein.

5 Non-Binding

The matters recorded in this SoC represent the expression of sincere intention by the Parties. Until such intention is embodied in a binding written agreement, such expression of intention will not be legally binding upon the Parties.


6 Use of Trademarks

The names, crests and logos of each Party are the intellectual property of that Party, and may not be used without that Party's express written permission for each specific usage.


