



## MEMORANDUM OF UNDERSTANDING

# BETWEEN PUNJABI UNVERSITY PATIALA, PUNJAB, INDIA AND UNIVERSITAS NEGERI YOGYAKARTA, INDONESIA

# No: T/468/UN34/HK.06/2019

In accordance with the principle of mutual desire to promote international cooperation between India and Republic of Indonesia, Punjabi University Patiala and Universitas Negeri Yogyakarta join in the following agreement for cultural, educational and scientific cooperation.

### Objective

The objective of this Memorandum of Understanding is to promote ties between Punjabi University Patiala and Universitas Negeri Yogyakarta and to promote exchange between the two Universities.

### **Scope of Collaboration**

Cooperation under the Memorandum of Understanding (MoU) shall include, inter alia, and as appropriate, the following:

- 1. Joint teaching arrangements for post-graduate programs;
- 2. Joint supervision of post-graduate research activities/projects;
- 3. Dual credential programs;
- 4. Faculty and Student exchange visit;
- 5. Joint student mobility programs;
- 6. Exchange of community services including exchange of social-cultural activities;
- 7. Exchange of academic information, publications and best practices;
- 8. Both universities may allow/provide faculties to visiting scholars, to participate as adjunct professors if the need arises from either party;
- 9. Library and documentation exchange;
- 10. Exchange of pedagogical material;
- 11. Joint application for funding including development funds and research grants;

- 12. Participation in joint academic seminars and workshops;
- 13. Development and implementation of other joint activities addressing issues of mutual interest, designed to foster research and demand driven community service, technology transfer and education capacities in the locality;
- 14. Any other collaborative efforts as may be determined by both parties.

# **Exchange of information**

- 1. The parties shall regularly exchange information and seek complementarities and coordination regarding their relevant activities and programs.
- 2. The parties may invite each other to participate in activities, working groups, conferences and seminars that are not directly part of this MoU but that may be relevant to it, in conformity with respective applicable rules.

# **Financial Obligations**

- All activities to be developed and implemented under this MoU will be subject to the
  availability of funds, either from the Parties' own resources or from donors. The Parties will
  engage in joint resource mobilization from governmental and non-governmental funding
  sources, including international donor organizations, private sector and philanthropic funds
  and non-governmental organizations, in accordance with relevant rules and procedures.
- 2. The descriptions and budgets of actions to be jointly undertaken will be part of separate activity based Agreement, which will refer to this MoU and be signed by the respective Parties involved including donors, if any, prior to the initiation of any activity.
- 3. Both institution shall seek waiver of duty and value added tax applicable in their respective countries on any equipment and materials obtained from either country for use by students and staff participating in this collaboration. As a general rule, the title and custody of any equipment acquired in the course of collaboration shall remain with the host institution upon the expiry of that particular project as specified in individual 'agreements of collaboration'.

# Responsibilities -Both parties agree to

- 1. Maintain regular communication and meet as deemed necessary in-person
- 2. Develop a plan for collaborative initiatives
- 3. Work in their area of framework to support initiatives.

### **Intellectual Property**

Where either party has any intellectual property rights in any material that is subsequently used by the parties in connection with this MoU, when those intellectual property rights remain vested in that party.

- 1. Copy right of information as well as any other intellectual property rights, developed jointly by Parties shall be jointly vested in the Parties concerned. Likewise the owners and authors of research initiatives will remain with the two parties; hence, the dissemination of finding and publication will be made with equal recognition of two institutions. Without the consent of the two organizations the date will not be used for any purpose without a prior permission of the two parties;
- 2. Intellectual property rights, in particular copyright on material such as information, software and designs, made available by any of the Parties to carry out the activities under this MoU shall remain with the originating party;
- 3. Each party agrees to do such further things as may reasonably be required of it to give effect to the intentions of the parties regarding ownership of intellectual property rights as expressed in this clause (including, without limitation, by executing such assignments and licenses of intellectual property rights as may reasonably be required).

### Plan of Action

Based on this MoU, Punjabi University Patiala and Universitas Negeri Yogyakarta agree to assist each other in drawing up and carrying out the concrete contents of the research project if they develop various activity plans in different areas. Details of these plans will be set up in a separate addendum to this memorandum.

### **Duration and Termination**

The MoU will be valid for five (5) years, it will be valid once it is signed by the official representatives of two universities. If either party wants to terminate this agreement, written notice needs to be given to the other party six (6) months before the termination of this agreement. However, the on-going projects should be continued to the end and not be affected by the termination of agreement. Two (2) copies of the agreement will be signed in English. Both copies are recognized as formal documents.

MoU shall not affect the National security and integrity of both the nations in any manner.
